The main purpose of this document is to provide the Design Specifications from the User Interface perspective to meet the requirements referenced in the following requirement documents:




Appendix B – Human Readable Layout:

Notes:

- All fields will display even if data is not populated or not applicable.
- Formatting and layout rules (i.e., plain text, courier font, portrait orientation) from Muni 1.0 apply to Muni 3.0.
- There will be now be four record types – Estimated Payments, Extension of Time to File, Net Profits Return and Withholding Payment. For the initial release, Estimated Payments, Extension of Time to File, and Net Profits Return will be grouped onto one report. The Withholding Payment activity will appear on a separate activity report.
- The first line of the file contains the version number and total dollars.
- The Muni Withholding report will follow the naming convention of the Muni Tax report, but with a change to the report identifier field. Currently, the Muni ID, Report Identifier, and date/timestamp are defined.
- Muni Withholding will also have the Human/Machine identity for MWH or MWM name.

Organization

The machine readable format file will be ordered by taxpayer.

In a single record you can see all municipalities that a taxpayer is filing for during the session that they were logged in. Each municipality that a taxpayer filed with for the session can be seen as a detail entry for the taxpayer record.

All fields marked "Required" will have a real value entered for the field value. Fields marked Optional will either be empty or have a real value. In either case, they will be represented in this pipe delimited file.

This file format is targeted to meet a common file format that can be accepted by all municipalities and TPAs.
